



## TCG Secure WEB Site Account Request

To facilitate the secure electronic exchange of technical data and customer support information, Curtiss-Wright has established a secure server on the Internet (<https://steps.g2tcg.com/>). This server is https secured and may be used for the electronic exchange of proprietary, ITAR, FOUO, software, or other controlled unclassified information between Curtiss-Wright and its customers. **NOTE: the site is NOT cleared for US classified or classified foreign information.**

Site Access is controlled by user account and password. Accounts and passwords are issued by Curtiss-Wright. **1. Site Information:** Users are advised of the following:

- The site is for **UNCLASSIFIED data only**. Any posting of classified information to the site is a reportable security violation.
- Downloads from the site shall be limited by users to platforms that are under the customer’s corporate control.
- Do not access the site from platforms outside of your corporate control such as a public computer.
- Accounts have unique access privileges and shall not be shared.
- All site activities are automatically logged and monitored by Curtiss-Wright.
- The site can be used to exchange any file type. The maximum file size that can be handled is 10 GB per file. (Note: The ability to receive large file sizes may be limited by your local LAN restrictions which are not under the control of Curtiss-Wright).
- Curtiss-Wright reserves the right to remove any data from the site at any time.
- Proprietary materials shall not be posted without executed NDAs in effect.
- For non-US clients, ITAR regulations require either a TAA or export license be in effect prior to posting ITAR-controlled information on the site.
